

## **2.412 CONCURRENT JURISDICTION-Prince George's County Police**

### **2.412.10 Authority**

- A. The agency and the Prince George's County Police have entered into an agreement pursuant to ED 13-601(b)(2) for the coordination of enforcement responsibilities within an area of concurrent jurisdiction that is adjoining property owned or operated by the University of Maryland, College Park.
- B. A copy of the concurrent jurisdiction agreement accompanies this directive.
  - 1. The attached copy of the agreement is for informational purposes only and is not suitable for introduction as evidence in court or administrative cases.
  - 2. Certified, true test copies of the agreement may be checked out from the Records Unit for introduction as evidence in court or administrative cases.

### **2.412.20 Limitations on Concurrent Jurisdictional Authority**

- A. The concurrent jurisdictional agreement places limitations on the authority of officers of this agency when responding to certain specified incidents.
- B. In these incidents, officers from this agency may not exercise police powers unless an apprehension can be made as the result of fresh pursuit, incident to fresh pursuit, or on the scene of the offense. These incidents are:
  - 1. Part I offenses established by FBI Uniform Crime Report (UCR) definitions;
  - 2. All deaths, including those occurring as the result of motor vehicle accidents;
  - 3. All cases of suspected child abuse; and
  - 4. Crimes occurring on Prince George's County school property.
- C. Part I offenses established by FBI UCR definitions are:
  - 1. Criminal homicide;
  - 2. Forcible rape;
  - 3. Robbery
  - 4. Aggravated assault;
  - 5. Burglary;
  - 6. Theft (excepting motor vehicle theft);
  - 7. Motor vehicle theft; and
  - 8. Arson.

### **2.412.30 Operational Details**

- A. When calls for service within the area of concurrent jurisdiction are received by this agency, agency personnel will immediately transfer calls to PGPD after informing callers that the reason for the transfer is that PGPD is the agency of primary jurisdiction.
  - 1. Requests for assistance may be referred by PGPD to this agency, providing officers from this agency are available to handle the request for service in the area of concurrent jurisdiction.
  - 2. Should officers from this agency be unable to respond, PGPD will be responsible for responding to the requests for assistance as the agency with primary jurisdiction.
- B. When calls for service within the area of concurrent jurisdiction are received by PGPD and subsequently referred to this agency, agency personnel will gather sufficient information so that officers from this agency may respond as the agency with secondary jurisdiction. However, should officers from this agency be unable to respond, PGPD will be responsible for responding to the requests for assistance as the agency with primary jurisdiction.
- C. CCNs will be generated for all calls for service received by this agency in the area of concurrent jurisdiction, whether the calls are initiated by citizens, officers from this agency, or referred to this agency by PGPD.
- D. All reports taken in the area of concurrent jurisdiction by officers from this agency will contain a PGPD CCN.
- E. Records Unit personnel will, on the first business day following

the filing of concurrent jurisdiction reports, forward copies of all applicable documents to the Hyattsville District of PGPD. Report copies may be mailed, hand carried, or sent via FAX.

- F. All arrests made in the area of concurrent jurisdiction by officers of this agency will be processed at the RPC consistent with **2.620 Processing Arrestees**. Arrest paperwork and reports related to arrests in the area of concurrent jurisdiction will be referenced with appropriate PGPD CCNs.
