

### 2.453 SALES OF GOODS ON &/OR USE OF UNIVERSITY FACILITIES

- A. The sale of goods and services on University property must be consistent with applicable University directives, State laws, and Prince George's County Codes.
1. Applicable University directives include, but are not limited to:
    - a. VI-4.10(A) UMCP Procedures for the use of physical facilities, Consolidated USMH & UMCP Policies and Procedures Manual;
    - b. VIII-6.00(A) UMCP Policy and Procedures Concerning the Sale of Goods and Services, Consolidated USMH & UMCP Policies and Procedures Manual; and
    - c. X-8.00(A) UMCP Policy on Ticket Sales at or Near Cole Field House or Byrd Stadium, Consolidated USMH & UMCP Policies and Procedures Manual.
  2. Individuals or groups wanting to sell goods or services on University property will be referred to Procurement and Supply in the Chesapeake Building.
  3. Proof of permission to sell goods or services on University Property must be in the form of approved contracts by Procurement and Supply.
  4. Consistent with Tax General (TG) 13-1016, it is a misdemeanor to engage in business without sales and use tax licenses as mandated by TG 11-702. See also **2.416 Criminal / Civil / Juvenile Citations**.
  5. Consistent with Business Regulation (BR) 17-1804, it is a misdemeanor to do business as a trader or exhibitor without a trader's license. See also **2.416 Criminal / Civil / Juvenile Citations**.
  6. BR 17-20A01, *et. seq.*, contains controlling language relating to transient vendors. BR 17-20A-04 specifies procedures by which officers may declare goods as contraband for potential seizure. Consistent with BR 17-20A-05, it is a misdemeanor for transient vendors to conduct business without displaying valid transient vendor licenses. See also **2.416 Criminal / Civil / Juvenile Citations**.
  7. Prince George's County Code Div. 12, Sec. 5-193.01 contains controlling language relating to sales, solicitations, distributions, etc. on, along, next to, etc. roadways, right-of-way, intersections, etc. Violations are misdemeanors. See also **2.416 Criminal / Civil / Juvenile Citations**.
  8. Prince George's County Code Div. 15, Sec. 5-201, *et. seq.*, contains controlling language relating to door-to-door solicitors. Consistent with Sec. 5-207.09, it is a misdemeanor (\$1000 fine / 6 months jail) to act in the capacity of a door-to-door solicitor without a license or continuing to act after licenses are denied, suspended, or revoked.
  9. Lack of official permission to sell goods or services on University property may constitute violations of ED 26-101, ED 26-102, or CR 6-409. See also **2.460 Trespassing**.
- B. The use of University space or facilities must be consistent with University directives.
1. These directives include, but are not limited to:
    - a. VI-4.10(A) UMCP Procedures for the Use of Physical Facilities, Consolidated USMH & UMCP Policies and Procedures Manual; and
    - b. Event Management Handbook, Stamp Student Union and Office of Campus Programs.
  2. Individuals or groups wanting to use University space or facilities will be referred to Campus Programs in the Stamp Student Union.
  3. Proof of permission to use University space or facilities must be

in the form of approved space reservations forms, listings on Campus Programs publications, etc.

4. Lack of official permission to use University space or facilities may constitute violations of ED 26-102, CR 6-402, CR 6-403, and CR 6-409. See also **2.460 Trespassing**.
